**COST:** *Merely* \$111. Registration deadline is JUNE 30<sup>th</sup> and caps out at 120 hashers, whichever cums first. **Your check / registration / campground waivers must be received before your registration is complete! NO DOGS OR PETS ALLOWED**

**T.I.T.S REGISTRATION 2011 AMENITIES:** Six “permanent” 8’ X 12’ tents on wooden platforms that will accommodate 6 normal humans. A fully equipped kitchen and several shower facilities with hot water are in the main building on the upper camping level. There is plenty of space for personal tents to be set up too. However the size of the facility requires limiting the number of hashers to the first 120 who register. **Parking:** In order to allow for the majority of us to camp on the upper level near the amenities and also to maintain a passable driveway, we ask that you park your vehicle in the field across the street from the main camping area after off-loading your gear at your chosen campsite.
